1A: Innovative Approaches to Managing and Treating Pediatric Chronic Conditions
This presentation explores special considerations for the effective management of children with type 1 diabetes or obesity. Type 1 diabetes management for children living in rural parts of Arizona will be reviewed, as well as the application of an emerging pediatric obesity program, MEND, to a mixed English-Spanish speaking population. The geographic, socioeconomic, and cultural barriers to pediatric health condition management will be discussed. Evidence-based recommendations will be made for how to a) improve glycemic control and reduce hospitalizations for a type 1 diabetes pediatric population and b) reduce or maintain BMI, increase cardiovascular fitness and change whole family health behaviors in an obese pediatric population. The importance of a patient-centered community-based model of care in effectively addressing pediatric chronic health conditions will be emphasized.
